CORPORATE EXHIBIT RULES & ARRANGEMENTS:

1. **SET UP OF ALL STALLS: On Friday, 24 May from 07h00 to 18h00 ONLY**
There will be Security on the property from 17h00, 24th till 7h00 on the 27th. All vehicles and personnel must vacate the property by 19h00 on Friday 24 May.
2. **NO MERCHANDISE WILL BE ALLOWED ONTO THE PROPERTY AFTER 8h30 ON SATURDAY 25 May 2019** All vehicles and personnel without valid Air show armbands must leave the premises by 8h30 on Saturday 25 May. **Any person found without a valid Air Show armband will be fined P500 and removed.**
3. **All delivery vehicles** must be out of the Air Show terrain by 8h30 on Saturday 25 May. **ALL VEHICLES WILL BE TOWED AWAY AND IMPOUNDED OR CLAMPED THAT IS FOUND ON THE PREMISES AFTER 18h00 on Friday 24th of May and between 9h00 and 17h00 on Saturday 25th of May. A FINE OF P1000 WILL BE CHARGED PER VEHICLE AND WILL BE PAID BEFORE THE VEHICLE IS RELEASED.**
4. Removal of Stall and Merchandise will be allowed on Saturday 25th from **17h00** till 18h30 and on Sunday 26th of May between 7h00 and 17h00 **ONLY. Vehicles and personnel will ONLY be allowed back on the premises at 17h00 on Saturday 25th.**
5. Please hand in the day before the event or email a signed copy of this document to Carla at carlabotswanaairshow@gmail.com
6. You will be provided with 4 Corporate Exhibitor entry tickets, one allocated 10m x 10m space and 2 vehicle entry disk. **The vehicle must be parked in the allocated parking Area no 3 for the duration of the Airshow.** You need to arrange Stationary Parking Discs for vehicles on display prior to Friday 24 May 2019. These vehicles will not be allowed to drive on the Airshow grounds at all. You will be fined and removed from the Airshow if you do not adhere to this arrangement.
7. If you want to bring with you any additional helpers you need to purchase additional entry tickets at P 120 per Adult; P 60 per child U18; also collect an entry ticket for all pre-school children from us, they are free.

- **PARTICIPANTS ARE NOT ALLOWED TO SELL ANY FOOD, DRINKS AND/OR PLASTIC HAND GUNS, RIFLES OR FIREWORKS NO TOY WEAPONS.**
- All participants need to provide their own equipment, e.g. tables, chairs and roofing.
- No electricity supply will be available for exhibitors.
- All participants are requested to please make sure that their stands are clean when they leave.
- Delivery and set up/installation of structures and equipment must be finalised on the Friday @ 18:00 prior to the event as NO access will be granted after 08h00 on the day of the event for the set-up of any display.
